4. FIRST AID MEASURES

Inhalation	Do not breathe vapour. In case of persistent symptoms, consult doctor.
Eye Contact	Rinse with plenty of water, until irritation subsides (at least 15 minutes). If irritation persists, seek medical advice.
Ingestion	Do not induce vomiting. Wash out mouth with water. Get prompt medical attention.
Skin Contact	Wash with plenty of soap and water after use. Remove grossly contaminated clothing & launder before re-use. If irritation occurs, get medical attention.

5. FIRE FIGHTING MEASURES

Extinguishing Media	Foam, dry chemical, carbon dioxide (CO ₂).
Media NOT to be Used	Water jet.
Special Precautions	Beware slippery conditions.
Hazardous Combustion Products	Fumes, smoke, carbon dioxide (CO ₂), and carbon monoxide (CO).
Protection for fire-fighters	Self-contained breathing apparatus. Where protective clothing to avoid contact with skin and eyes. Ensure clothing is solvent resistant.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions	Beware slippery conditions.
Small Spills	Scrape up into a suitable container.
Large Spills	Collect the spill in a suitable container. Prevent from entering sewers, watercourses or low areas.
Disposal	Use authorised waste disposal method.

7. HANDLING AND STORAGE

Handling	Avoid contact with eyes and unnecessary skin contact. Observe normal levels of industrial hygiene. Avoid inhalation of mists and vapours - use in a well ventilated area. Never mix with other chemical products.
Storage	Keep away from strong oxidising agents. Store in well ventilated conditions, out of direct sunlight in clearly labelled, unopened original containers below 20oC. Protect from heat, sources of ignition and humidity.
